Match Point Tournament Participation Guide

Item 36. Unless otherwise stated in the MPTC governing rules, USTA rules for match play shall apply "USTA Friend of the Court"

Part 2 - The Code: Player's guide for matches when officials are not present
 Note: *The Code* is not part of the official ITF Rules of Tennis. Players shall follow *The Code* in all unofficiated matches. Many of the principles also apply when officials are present.

PRINCIPLES

1. *Courtesy.* Tennis is a game that requires Cooperation and Courtesy from all participants. Make tennis a fun game by praising your opponent's good shots and by not:

- * Conducting loud postmortems after points
- * Complaining about shots like lobs and drop shots
- * Embarrassing a week opponent by being overly gracious or condescending
- * Losing your temper, using vile language, throwing your racquet, or slamming a ball in anger
- * Sulking when you are losing.
