Match Point Tournament Seeding Guidelines

The goal is to have seeded teams (doubles)/persons (singles) meet in the semifinals (16 entry draw) or quarterfinals (32 entry draw) using any reasonable process to achieve the goal. Doing this should also avoid having two of the stronger entries meet in the first round where the loser of that match would be highly likely to win the consolation side of the draw. Our opinion is that any first round loser should have a reasonable opportunity to win the consolation side of the draw.

To achieve this goal, the normal process used at the draw is as follows:

1. The division reps are provided with the points earned during the last 12 months for the type of tournament (singles/doubles/mixed) being played that month. The general opinion is that people have

different strengths for each type of tournament. Our expectation also is that the reps should know about the overall strength of the people in their division.

2. New members or recent move-downs from a higher division are noted for the reps.

3. Using the above information or anything else they know about the entrants, the reps are expected to seed the entrants to achieve the above stated goal.

4. If no other information or knowledge about the person/teams is available, then the suggested method is to use the points earned for that type tournament over the past 12 months.
